Policies for Deposits, Tuition, and Fees:

1. Enrollment at Beacon is a financial commitment for the academic year.
2. **One-time Fees**
 - a. **Matriculation Fee** is a one-time, **non-refundable** fee due for all new students joining Beacon from Kinder-Grade 8.
 - b. **Capital Development Fee (CDF)** is a one-time fee payable in pesos for all students entering Kindergarten to G8. Parents may opt for a **Refundable CDF**, which is payable once the child withdraws or graduates from the school or **Non-refundable CDF**. CDF refunds will be processed within 45 days from date of formal withdrawal, and upon completion of school clearance. No interest will accrue on CDF deposits. In case of default on any tuition, fees or penalties, the Capital Development Fee (for refundable CDF only) will be applied against all unpaid obligations to the school.



3. Deposits and Re-enrollment Fees:

- a. **New students are subject to an Enrollment Deposit** to secure their slot for the next school year. The Enrollment Deposit is **non-refundable and non-transferrable** but applicable to tuition fees due. If a new student subsequently withdraws prior to enrollment, the Enrollment Deposit is forfeited. The due date is indicated in the offer letter.
- b. **A Returning Student Fee for returning students** is required to reserve a slot for the following school year. This fee is applicable to tuition due but is **non-refundable and non-transferrable** should the student subsequently withdraw from the school.

4. Tuition Terms

- a. For parents opting to pay tuition payments on a trimestral basis, if a withdrawal occurs at any time during the school year, **unpaid trimestral tuition payments for the remainder of the school year will remain due and payable.**
- b. For students who enter the school after the start of the academic year, tuition will be paid in full for the trimester in which the student begins and for the rest of the year. Fees are not pro-rated, regardless of the date of enrollment.
- c. Parents are encouraged to remit tuition payments using bank transfers directly to the Beacon School bank accounts with details outlined in your tuition bills. Alternatively, cheques can also be used. **Cash payments are strongly discouraged.**
- d. Tuition is **NON-REFUNDABLE and NON-TRANSFERRABLE.**

5. Other Fees

- a. **School activities & field trip subsidy fee** covers IDs, car stickers, yearbooks, partial coverage of field trips, and school supplies. The fee entitles each family to up to 4 security swipe cards, 4 vehicle stickers, 1 yearbook per child, school supplies packet and provides a partial subsidy for the numerous school trips taken during the year as well as partial subsidy for afternoon activities. Families requiring additional swipe cards, stickers or yearbooks may arrange to purchase them from the reception counter at the school. The school offers several optional afternoon



activities, and sports programs. Please refer to the activities brochures or to the reception desk.

- b. The school offers an optional lunch program for an additional cost. Please refer to the meal program brochure or inquire at the reception desk at the start of each term for details.
- c. A fee of P10,000 per month shall be charged to students requiring the services of an additional Educational Assistant to ensure student safety, due to a particular student's ongoing behavioral challenges.
- d. Fees are not pro-rated, or refunded, regardless of the date of enrollment or withdrawal.

6. Terms regarding Non –Payment of Tuition and Fees

- a. **No child will be permitted to begin school or return to class if the current tuition and fees bill is not paid in full.** Late payments of tuition and fees will be subject to a **2% per month** interest rate or a **PHP 3,000** penalty, whichever is greater.
- b. **Academic and other school records will not be released to parents until all financial obligations are settled.**
